- (i) all money due to the listed issuer in respect of the issue of securities has been settled in accordance with the terms of the Post-IPO Share Option Scheme II and 2023 Share Option Scheme.  
Remark: In relation to the issue of 783,888 shares at the issue price of HK\$185.65 per share, as part of the arrangement to settle the exercise price in a cashless manner, the option holder exercised 3,400,000 share options under Post-IPO Share Option Scheme II on 19 December 2023. The automatic deduction of 2,616,112 shares represents the consideration payable for the exercise of 3,400,000 share options (such that 783,888 shares were issued after the netting off). The issue of the remaining 11,425 shares relates to the exercise of 11,425 share options under 2023 Share Option Scheme and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 10); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue.
