Remark: Out of 92,937 issued shares, 27,110 shares are issued as part of the arrangement for option holders to settle the exercise price in respect of the exercise of 57,706 share options in a cashless manner on 1 September 2025. The automatic deduction of 30,596 shares represents the consideration payable for the exercise of 57,706 share options (such that 27,110 shares were issued after the netting off). The issue of the remaining 65,827 shares relates to the exercise of 65,827 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
