The automatic deduction of 1,447,073 shares represents the consideration payable for the exercise of 2,916,667 share options (such that 1,469,594 shares were issued after the netting off). The issue of the remaining 26,199 shares relates to the exercise of 26,199 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
