The automatic deduction of 27,954 shares represents the consideration payable for the exercise of 57,707 share options (such that 29,753 shares were issued after the netting off). The issue of the remaining 65,403 shares relates to the exercise of 65,403 share options and has been settled in cash;

- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
