The automatic deduction of 141,904 shares represents the consideration payable for the exercise of 293,055 share options (such that 151,151 shares were issued after the netting off). The issue of the remaining 93,236 shares relates to the exercise of 93,236 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
