- (i) all money due to the listed issuer in respect of the issue of shares, or sale or transfer of treasury shares has been settled in accordance with the terms of 2023 Share Option Scheme. Remark: Out of 49,493 issued shares, 48,593 shares are issued as part of the arrangement for option holders to settle the exercise price in respect of the exercise of 100,000 share options in a cashless manner on 7 January 2026. The automatic deduction of 51,407 shares represents the consideration payable for the exercise of 100,000 share options (such that 48,593 shares were issued after the netting off). The issue of the remaining 900 shares relates to the exercise of 900 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
