Remark: Out of 807,469 issued shares, 775,172 shares are issued as part of the arrangement for option holders to settle the exercise price in respect of the exercise of 2,875,000 share options in a cashless manner on 13 January 2026. The automatic deduction of 2,099,828 shares represents the consideration payable for the exercise of 2,875,000 share options (such that 775,172 shares were issued after the netting off). The issue of the remaining 32,297 shares relates to the exercise of 32,297 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
