Remark: Out of 1,609,024 issued shares, 1,544,120 shares are issued as part of the arrangement for option holders to settle the exercise price in respect of the exercise of 3,123,333 share options in a cashless manner on 14 January 2026. The automatic deduction of 1,579,213 shares represents the consideration payable for the exercise of 3,123,333 share options (such that 1,544,120 shares were issued after the netting off). The issue of the remaining 64,904 shares relates to the exercise of 64,904 share options and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 8); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue, sale or transfer.
